2. Scope of Data

3. Data Security Commitments

- All data must be encrypted at rest using AES-256 encryption and in transit using TLS 1.2 or higher.
- Role-based access control shall be implemented on the admin dashboard to ensure limited access based on user roles.
- Comprehensive audit logs shall be maintained for all data accesses and modifications.
- No sensitive data shall be stored in frontend HTML or exposed via browser developer tools or inspect element.

4. Responsibilities of Aamod IT Solutions Pvt Ltd

- Ensure all data collection, storage, processing, and deletion complies fully with India's **Data Protection and Privacy Act (DPDP) 2023**.
- Accept complete accountability for any unauthorized access, data leak, or data breach.
- Provide regular backups and implement robust data recovery mechanisms.
- Submit a load testing report demonstrating system capability to handle 1,200 concurrent students per hour per category.
- Implement security measures including but not limited to HTTPS, API rate limiting, and IP restrictions.

5. Data Retention & Destruction

- All project-related data must be securely deleted from all servers and backups upon project completion, unless otherwise agreed upon in writing.
- Temporary or staging/test data must be purged within 7 days following completion of User Acceptance Testing (UAT).

6. Liability Clause

- In the event of any data breach, leak, or unauthorized access, Aamod IT Solutions Pvt Ltd shall be the sole party held responsible.
- Sodhani Academy of Fintech Enablers Ltd and any individual or entity associated with NFLO shall be indemnified and exempt from any legal, financial, or reputational liability arising from such incidents.

Security & Privacy Requirements:

- No personal or sensitive data should be visible via inspect element or frontend HTML.
- All input forms must be protected against CSRF and XSS attacks.
- OTPs and passwords must be stored using one-way hashing algorithms (bcrypt or similar).
- Content Security Policy (CSP) headers and Cross-Origin Resource Sharing (CORS) protections must be enabled.

Performance & Load Handling:

- The platform must support 5000 concurrent users including all category per hour.
- Mock exams must be conducted and load testing proof provided.
- Dynamic question sets should be delivered uniquely per user session.

Uptime and Monitoring:

- Maintain **99.9**% **uptime** during the full 15-day exam window.
- Provide a real-time monitoring dashboard accessible to the Sodhani Academy team.
- Send immediate downtime alerts via email and SMS to designated technical contacts.
